**PARKING:** Parking will be assigned prior to the event--one space per vendor. Show time is 9:00 am to 5:00 pm Saturday and 10:00 am to 4:30 pm Sunday. Must be setup 1/2 hour prior to show time.

**RULES:**

1. Vendors shall stay within their allotted space and are responsible for maintaining a clean appearance
2. Show Registration Card must be posted clearly with prices and visible from 6-8 ft. from ordering spot.
3. Vendors must collect and pay 6% Florida Sales Tax.
4. Vendor must have current food service permit and furnish a copy of **Liability Insurance with Homosassa Civic Club listed as an additional insured.**
5. Vendor shall not serve additional food items or food items awarded exclusively to other vendors.
6. Food waste and burnt oils shall be legally disposed of in proper containers. If a vendor is found to have improperly disposed of food water or eatable oils, they will be fined a \$250 cleaning fee.
7. Pets shall not be allowed in the food court or food preparation areas.
8. All areas utilized by the public must be frequently cleaned and sanitized.

**DECLARATION:**

The Homosassa Civic Club sponsors the Homosassa Arts, Crafts, and Seafood Festival as a public service to the community. Fees paid are non-refundable after the notification date. The festival will proceed as scheduled, rain or shine. The Homosassa Civic Club offers no guarantees on weather conditions, public attendance or financial success.
